The respondent shall not disclose, publish, or advertise this specification or related information to any third party without the prior written consent of TASEZ.

#### **2.2.2.** Enquiries and Communication

Bidders may not contact any other TASEZ employee besides contact person mentioned on Paragraph 2.2.2.1 above on any matter pertaining to the bid from the time when bid is advertised to the time the bid is awarded. Any effort by a bidder to influence bid evaluation, bid comparisons or bid award decisions in any manner, may result in rejection of the bid concerned.

#### 3. Scope of Work

TASEZ hereby invites proposals from suitably qualified bidders for the provision of maintenance service of all the air conditioning units in its facilities. Please refer to Appendix A for a detailed specification of the air conditioning units across the TASEZ facilities. -HVAC BOQ

- **3.1.** Air conditioner units will be accessed via ladder and cat ladder to rooftop access. Safety harnesses and general accepted safe height work procedure required.
  - **3.2.** Bidders are required to provide the comprehensive maintenance of equipment in accordance with the relevant SANS and manufacturer recommendations of the following HVAC systems installed at Phase 1 and Phase 1A.

#### 3.2.1. Preventative maintenance

- 3.2.1.1. Unless superseded by more stringent requirements of these specifications or code requirements, all maintenance service shall conform to the requirements of the following standards: SANS 10400, SANS 10139, SANS 1929:200, SANS 10147
- 3.2.1.2. Perform the minimum service as per the manufacturer's recommended maintenance schedule for each HVAC item/system as per the maintenance frequency schedule table below, or at more frequent intervals when it is necessary to maintain satisfactory operation or recommended by the equipment manufacture, following the manufacturer recommended service procedures.
- 3.2.1.3. Perform a complete operational check of each item/system and adjust or repair equipment as required to maintain operation within manufacturers tolerances and recommendations.
- 3.2.1.4. Check operating components requiring periodic lubrication. Lubricate as necessary, following manufacture's recommendations and specifications.

#### 3.2.3. Emergency service

- 3.2.3.1. To ensure that HVAC equipment is fully operational at all times, the service provider shall provide emergency/call out service on an asneeded basis. Such call out service shall be provided twenty-four (24) hours per day, seven days a week.
- 3.2.3.2. Response to an emergency call out shall consist of providing an HVAC technician on site within the above time frames, after being notified of an HVAC emergency.
